

**WEST 1/16 CORNER SOUTHWEST QUARTER SECTION 19, TOWNSHIP 15 SOUTH, RANGE 11 EAST**

- 1) MATTHEW BROWN, DEPUTY COUNTY SURVEYOR, FOR R. H. EDMISTON, COUNTY SURVEYOR FROM 1884 TO 1887, IN SURVEY NUMBER 72, AN **AGREEMENT SURVEY** FOR GEORGE MOSS AND GEORGE W, GORMAN TO SURVEY AND SUBDIVIDE PARTS OF SECTIONS 19, 20 30 & 31 IN TOWNSHIP 15, RANGE 11 RECORDED IN SURVEY BOOK "E" ON PAGE 72 BUT NOT DATED, SAID THAT **HE SET A LIMESTONE 3" X 18" X 12" AT THE BASE WITH THE TOP POINTED MARKED "1/8"** FOR THE WEST 1/8<sup>TH</sup> CORNER OF THE SOUTHWEST 1/4 OF SECTION 19-15-11 AT 1,320' NORTH OF THE STONE THAT HE SET FOR THE SOUTHWEST CORNER OF SECTION 19-15-11 ON THE RANGE LINE ON THIS **AGREEMENT SURVEY**. THIS SURVEY WAS RECORDED IN MISCELLANEOUS VOLUME 41 ON PAGE 25 IN THE REGISTER OF DEEDS OFFICE ON JANUARY 27, 1887 WITH THE NOTATION THAT IT WAS SURVEYED OCTOBER 27 & 28 AND NOVEMBER 6-8, 1884, WITH A COPY OF THIS SURVEY FILED AS SURVEY F19001 IN THE SURVEY FILE FOR TOWNSHIP 15-11.

**HIS SURVEY NOTES/DRAWING SHOWS THE FOLLOWING INFORMATION:**

- 1) 1,320' SOUTH ON THE RANGE LINE TO THE 4" X 12" X 18" LIMESTONE HE SET FOR THE CORNER TO SECTIONS 24 & 25 IN RANGE 10 AND SECTIONS 19 & 30 IN RANGE 11
- 2) 1,359' EAST TO THE 12" X 16" X 3" TRIANGULAR LIMESTONE HE SET FOR THE CENTER CORNER OF THE SW1/4 OF SECTION 19-15-11 ON THE RANGE LINE
- 3) 2,679' EAST TO THE 12" X 16" X 3" TRIANGULAR LIMESTONE SET FOR THE EAST 1/8<sup>TH</sup> CORNER OF THE SW1/4 OF SECTION 19-15-11
- 4) 3,999' EAST TO THE 12" X 3" X 16" TRIANGULAR LIMESTONE HE SET FOR THE CENTER CORNER OF THE SE1/4 OF SECTION 19-15-11
- 5) 5,319' EAST TO THE 10" X 15" X 3" LIMESTONE HE SET FOR THE EAST 1/8<sup>TH</sup> CORNER OF THE SE1/4 OF SECTION 19-15-11
