

**NORTH 1/6TH CORNER NORTHEAST QUARTER OF SECTION 03, TOWNSHIP 16 SOUTH,  
RANGE 11 EAST**

1) C. H. RICE, DEPUTY COUNTY SURVEYOR, IN A **PERMANENT SURVEY** RECORDED IN SURVEY BOOK "D" ON PAGES 139 & 140 DATED JANUARY 3-8, 1883 ORDERED BY GEORGE W. DeCAMP TO SURVEY SECTIONS 2, 3 & 4 IN TOWNSHIP 16, RANGE 11, SAID THAT **HE SET A STONE** FOR THE PERMANENT NORTH 1/8<sup>TH</sup> CORNER OF THE NORTHEAST 1/4 OF SECTION 3-16-11 ON THE 3<sup>RD</sup> STANDARD PARALLEL MIDWAY BETWEEN THE STONE THAT HE SET FOR THE PERMANENT NORTH 1/4 CORNER OF SECTION 3-16-11 AND THE STONE THAT HE SET FOR THE PERMANENT NORTHEAST CORNER OF SECTION 3-16-11 ON THIS **PERMANENT SURVEY**.

- 1) 19.82-1/2 CHAINS WEST ON THE 3<sup>RD</sup> STANDARD PARALLEL TO THE STONE HE SET FOR THE PERMANENT NORTH 1/4 CORNER OF SECTION 3-16-11
- 2) 59.46-3/4 CHAINS WEST ON THE 3<sup>RD</sup> STANDARD PARALLEL TO THE STONE HE SET FOR THE PERMANENT NORTHWEST CORNER OF SECTION 3-16-11
- 3) 99.46-3/4 CHAINS WEST ON THE 3<sup>RD</sup> STANDARD PARALLEL TO THE STONE HE SET FOR THE PERMANENT NORTH 1/4 CORNER OF SECTION 4-16-11
- 4) 19.82-1/2 CHAINS EAST ON THE 3<sup>RD</sup> STANDARD PARALLEL TO THE STONE HE SET FOR THE PERMANENT NORTHEAST CORNER OF SECTION 3-16-11
- 5) 59.46-3/4 CHAINS EAST ON THE 3<sup>RD</sup> STANDARD PARALLEL TO THE STONE HE SET FOR THE PERMANENT NORTH 1/4 CORNER OF SECTION 2-16-11
- 6) 79.29 CHAINS EAST ON THE 3<sup>RD</sup> STANDARD PARALLEL TO THE STONE HE SET FOR THE PERMANENT NORTH 1/8<sup>TH</sup> CORNER OF THE NE1/4 OF SECTION 2-16-11
- 7) 99.11-1/4 CHAINS EAST ON THE 3<sup>RD</sup> STANDARD PARALLEL TO THE STONE HE FOUND AT THE NORTHEAST CORNER OF SECTION 2-16-11
