

NORTH 1/16 CORNER OF THE SOUTHEAST 1/4 SECTION 29 TOWNSHIP 17 SOUTH, RANGE 10 EAST

- 1) ROBERT MILLIKEN, COUNTY SURVEYOR FROM 1870 TO 1875 AND FROM 1882 TO 1883, IN SURVEY NUMBER 48 OF THE 8TH TERM, A **PERMANENT SURVEY** RECORDED IN SURVEY BOOK "C" ON PAGE 105 DATED OCTOBER 28, 1874 TO SUBDIVIDE SECTION 29-17-10, SAID THAT **HE SET A STONE** FOR THE PERMANENT SOUTH 1/8TH CORNER OF THE NORTHEAST 1/4 OF SECTION 29-17-10 ON LINE AND HALFWAY BETWEEN THE STONE THAT HE SET FOR THE PERMANENT CENTER CORNER OF SECTION 29-17-10 AND THE STONE THAT HE FOUND AT THE EAST 1/4 CORNER OF SECTION 29-17-10 ON THIS **PERMANENT SURVEY**.

- 2) R. H. EDMISTON, COUNTY SURVEYOR FROM 1884 TO 1887, IN SURVEY NUMBER 81, A **PERMANENT SURVEY** ORDERED BY J. J. DOTY TO SURVEY SECTION 29-17-10 RECORDED IN SURVEY BOOK "E" ON PAGE 81 DATED DECEMBER 22-27, 1884 AND RECORDED IN VOLUME 41 ON PAGE 29 IN THE REGISTER OF DEEDS OFFICE ON JANUARY 27, 1887, SURVEY F29001 IN THE SURVEY FILE FOR TOWNSHIP 17-10, SAID THAT **HE SET A 4" X 15" X 18" STONE** FOR THE PERMANENT SOUTH 1/4/4 CORNER OF THE NORTHEAST 1/4 OF SECTION 29-17-10 ON LINE AND HALFWAY BETWEEN THE STONE THAT HE SET FOR THE PERMANENT CENTER CORNER OF SECTION 29-17-10 AND THE TEMPORARY STAKE THAT HE SET FOR THE EAST 1/4 CORNER OF SECTION 29-17-10 ON THIS **PERMANENT SURVEY**.
HIS SURVEY NOTES/DRAWING SHOWS THE FOLLOWING INFORMATION:
 - 1) 1,332.5' EAST TO THE TEMPORARY STAKE HE SET FOR THE EAST 1/4 CORNER OF SECTION 29-17-10
 - 2) 671.5' WEST TO THE 6" X 10" X 14" STONE HE SET ON THE INDIAN RESERVE LINE
 - 3) 1,332.5' WEST TO THE 4" X 5" X 30" STONE HE SET FOR THE PERMANENT CENTER CORNER OF SECTION 29-17-10
 - 4) 2,568' WEST TO THE 2" X 5" X 16" **REFERENCE STONE** HE SET FOR THE SOUTH 1/4/4 CORNER OF THE NW1/4 OF SECTION 29-17-10, AS THE TRUE POSITION FALLS IN THE NEOSHO RIVER
 - 5) 2,656.5' WEST TO THE TRUE POSITION FOR THE SOUTH 1/4/4 CORNER OF THE NW1/4 OF SECTION 29 – FALLS IN THE RIVER
 - 6) 3,980.5' WEST TO THE 5" X 5" X 16" STONE HE SET FOR THE PERMANENT WEST 1/4 CORNER OF SECTION 29-17-10
 - 7) 1,332.5' NORTH TO THE 3" X 8" X 15" STONE HE SET FOR THE PERMANENT CENTER CORNER OF THE NE1/4 OF SECTION 29-17-10
 - 8) 2,665' NORTH TO THE TEMPORARY STAKE HE SET FOR THE NORTH 1/4/4 CORNER OF THE NE1/4 OF SECTION 29-17-10
