

**NORTH 1/16<sup>TH</sup> CORNER OF SOUTHWEST 1/4 SECTION 06, TOWNSHIP 17 SOUTH, RANGE 11 EAST**

1) ROBERT MILLIKEN, COUNTY SURVEYOR FROM 1870 TO 1875 AND FROM 1882 TO 1883, IN SURVEY NUMBER 7 OF THE 8<sup>TH</sup> TERM, A **PERMANENT SURVEY** RECORDED IN SURVEY BOOK "C" ON PAGE 62 DATED MARCH 5, 1874 TO ESTABLISH THE CENTER CORNER, TO SUBDIVIDE THE SOUTHWEST 1/4 BY A LINE NORTH & SOUTH, THE SOUTHEAST 1/4 BY A LINE NORTH & SOUTH, THE EAST 1/2 OF THE NORTHWEST 1/4 BY A LINE EAST & WEST, THE NORTHEAST 1/4 BY A LINE NORTH & SOUTH, AND THE WEST 1/2 BY A LINE EAST & WEST, ALL IN SECTION 6-17-11, STATES **HE SET A STONE** FOR THE PERMANENT SOUTH 1/2/4 CORNER OF THE NORTHWEST 1/4 OF SECTION 6-17-11 ON THIS **PERMANENT SURVEY**.

**HIS SURVEY NOTES SHOW THE FOLLOWING INFORMATION:**

- 1) 1,320' NORTH TO THE STONE HE SET FOR THE PERMANENT 1/4/4 CORNER IN THE CENTER OF THE NW1/4 OF SECTION 6-17-11
- 2) 2,620' NORTH TO THE STONE HE SET FOR THE PERMANENT NORTH 1/2/4 CORNER OF THE NW1/4 OF SECTION 6-17-11 ON THE TOWNSHIP LINE
- 3) 1,003' WEST TO THE STONE HE FOUND AT THE WEST 1/4 CORNER OF SECTION 6-17-11 ON THE RANGE LINE
- 4) 1,320' EAST TO THE STONE HE SET FOR THE PERMANENT CENTER CORNER OF SECTION 6-17-11
- 5) 2,627-1/2' EAST TO THE STONE HE SET FOR THE PERMANENT SOUTH 1/2/4 CORNER OF THE NW1/4 OF SECTION 6-17-11
- 6) 3,935' EAST TO THE STONE HE FOUND AT THE EAST 1/4 CORNER OF SEC. 6-17-11
