

**CENTER CORNER SOUTHWEST QUARTER OF SECTION 14, TOWNSHIP 19 SOUTH,
RANGE 11 EAST**

- 1) W. D. KRETSINGER, L.S. 363, COUNTY ENGINEER FROM 1952 TO 1981, IN LARGE SURVEY SR#14013 IN THE SURVEY DRAWER FOR SECTIONS 11-16 IN TOWNSHIP 19-11 DATED MAY 1, 1951 SHOWS A **THEORETICAL LOCATION** FOR THE CENTER CORNER OF THE SOUTHWEST 1/4 OF SECTION 14-19-11.
HIS DRAWING SHOWS THE FOLLOWING INFORMATION:
 - 1) 1,327.66' NORTH TO A "MONUMENT" AT THE NORTHWEST CORNER OF THE NE1/4 OF THE SW1/4 OF SECTION 14-19-11 – NOT DESCRIBED
 - 2) 1,314.05' EAST TO THE 1/16TH CORNER – NOT DESCRIBED

- 2) LESLIE M. GOULD, L.S. 142, COUNTY SURVEYOR FROM 1953 TO 1978, IN LARGE SURVEY SR #14009 IN THE SURVEY DRAWER FOR SECTIONS 11-16 IN TOWNSHIP 19-11 DATED MARCH 5, 1965 SHOWS A "**MONUMENT**" AT THE SOUTHWEST CORNER OF THE NW1/4 OF THE SW1/4 OF SECTION 14-19-11. THERE IS NO DESCRIPTION OF THE MONUMENT AND THERE ARE NO TIES ON THE SURVEY.

- 3) LESLIE M. GOULD, L.S. 142, COUNTY SURVEYOR FROM 1953 TO 1978, IN A PLAT SHOWING THE RESULTS OF A **PERMANENT SURVEY** FOR TRACTS FOR PAUL LOOKER, KEITH RIDER, KANSAS POWER & LIGHT, AND D. F. WARNER IN THE NORTHWEST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 14-19-11 DATED MAY 2, 1968 RECORDED IN PERMANENT SURVEY BOOK 2 ON PGE 52 AND RECORDED IN VOLUME 5 OF PLATS ON PGE 43-A IN THE REGISTER OF DEEDS OFFICE ON MAY 24, 1986, SHOWS ON HIS SURVEY DRAWING A "**MONUMENT**" AT THE SOUTHEAST CORNER OF THE NORTHWEST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 14-19-11 ON THIS **PERMANENT SURVEY**. THERE IS NO DESCRIPTION OF THE MONUMENT AND THERE ARE NO TIES ON THE SURVEY OR THE SURVEY TIE FILES.
HIS SURVEY DRAWING SHOWS THE FOLLOWING INFORMATION:
 - 1) 1,323.8' NORTH TO THE NORTHEAST CORNER OF THE NW1/4 OF THE SW1/4 OF SECTION 14-19-11 – NOT IDENTIFIED
 - 2) 726.5' WEST TO THE STONE HE FOUND AT THE SOUTHWEST CORNER OF THE PAUL LOOKER TRACT AT THE SOUTH END OF A FENCE RUNNING NORTH
 - 3) 1,314.5' WEST TO THE SOUTHWEST CORNER OF THE NW1/4 OF THE SW1/4 OF SECTION 14-19-11 – NOT DESCRIBED
