

**WEST 1/16TH CORNER NORTHWEST QUARTER OF SECTION 17, TOWNSHIP 19 SOUTH,
RANGE 13 EAST**

- 1) ROBERT MILLIKEN, COUNTY SURVEYOR FROM 1870 TO 1875 AND FROM 1882 TO 1883, BY C. H. RICE, DEPUTY COUNTY SURVEYOR, IN A **PERMANENT SURVEY** RECORDED IN SURVEY BOOK "D" ON PAGE 121 AND DATED MARCH 1882, SAID THAT **HE SET A STONE** FOR THE WEST 1/16TH CORNER OF THE NORTHWEST 1/4 OF SECTION 17-19-13 ON THIS **PERMANENT SURVEY**.

- 2) GREGORY ALAN MILES, L.S 667, APPOINTED COUNTY SURVEYOR, IN A **PERMANENT SURVEY** RECORDED IN PERMANENT SURVEY BOOK 2 ON PAGE 58A FOR A REPLAT OF LOTS 5, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 22, 23, 24, 25, & 29 IN WAYMAN'S COUNTRY ESTATES BY THE ORDER OF BEN JOHNSON, THAT WAS COMPLETED ON APRIL 16, 1981 AFTER HAVING BEEN ADJOURNED FROM APRIL 9, 1981, SHOWS ON HIS SURVEY DRAWING A "**MONUMENT**" AT THE SOUTHEAST CORNER OF THE NORTHEAST 1/4 OF SECTION 18-19-13 ON THIS **PERMANENT SURVEY**. HE DOES NOT DESCRIBE THE MONUMENT THAT HE FOUND AT THE SOUTHEAST CORNER OF THE NORTHEAST 1/4 OF SECTION 18-19-13 IN HIS LEGEND AND THERE ARE NO TIES ON THE SURVEY OR IN THE SURVEY TIE FILES.
HIS SURVEY DRAWING SHOWS THE FOLLOWING INFORMATION:

 - 3) 30' WEST TO THE STEEL PIN HE SET SEPTEMBER 1980 FOR THE PERMANENT SOUTHEAST CORNER OF LOT 8
 - 4) 510.00' WEST TO THE STEEL PIN HE SET SEPTEMBER 1980 FOR THE PERMANENT SOUTHWEST CORNER OF LOT 8
 - 5) 685.00' WEST TO THE STEEL PIN HE SET SEPTEMBER 1980 FOR THE PERMANENT SOUTHWEST CORNER OF LOT 10
 - 6) 835.00' WEST TO THE STEEL PIN HE SET SEPTEMBER 1980 FOR THE PERMANENT SOUTHWEST CORNER OF LOT 11
 - 7) 985.00' WEST TO THE STEEL PIN HE SET SEPTEMBER 1980 FOR THE PERMANENT SOUTHWEST CORNER OF LOT 12
 - 8) 1,135.00' WEST TO THE STEEL PIN HE SET SEPTEMBER 1980 FOR THE PERMANENT SOUTHWEST CORNER OF LOT 13
