

**NORTH 1/16TH CORNER NORTHWEST QUARTER OF SECTION 15, TOWNSHIP 20 SOUTH,
RANGE 11 EAST**

- 1) ROBERT MILLIKEN, COUNTY SURVEYOR FROM 1870 TO 1875 AND FROM 1882 TO 1883, IN SURVEY NUMBER 111 OF THE 7TH TERM, A **PERMANENT SURVEY** RECORDED IN SURVEY BOOK "C" ON PAGE 33 DATED JUNE 18, 1873 TO ESTABLISH THE CENTER CORNER OF SECTION 10-20-11 AND TO ESTABLISH THE CORNERS COMMON TO THE EAST 1/2 OF THE EAST 1/2 OF THE SOUTHWEST 1/4 AND THE WEST 1/2 OF THE EAST 1/2 OF THE SOUTHWEST 1/4 OF SECTION 10, SAID THAT **HE SET A STONE** FOR THE PERMANENT SOUTH 1/2/4 CORNER OF THE SOUTHWEST 1/4 OF SECTION 10-20-11 ON LINE AND HALFWAY BETWEEN THE STONE THAT HE FOUND AT THE NORTHWEST CORNER AND THE STONE THAT HE FOUND AT THE NORTH 1/4 CORNER OF SECTION 10-20-11 ON THIS **PERMANENT SURVEY**.
HIS SURVEY NOTES/DRAWING SHOWS THE FOLLOWING INFORMATION:
 - 1) 1,321' WEST TO THE STONE HE FOUND AT THE NORTHWEST CORNER OF SECTION 10-20-11
 - 2) 660-1/2' EAST TO THE STONE HE SET FOR THE PERMANENT 1/4/4 CORNER ON THE SOUTH SIDE OF THE SW1/4 OF SECTION 10-20-11
 - 3) 1,321' EAST TO THE STONE HE FOUND AT THE NORTH 1/4 CORNER OF SECTION 10-20-11

- 2) ALVA J. SMITH, COUNTY SURVEYOR FROM 1900 THROUGH 1906, IN SURVEY NUMBER 45, A **PERMANENT SURVEY** RECORDED IN SURVEY BOOK "E" ON PAGE 226 DATED MARCH 25-31, 1902 ORDERED BY CHARLES EVANS FOR A SURVEY IN SECTION 3-20-11, SHOWS ON HIS DRAWING THAT **HE FOUND THE STONE** AT THE SOUTH 1/8TH CORNER OF THE SOUTHWEST 1/4 OF SECTION 10-20-11 ON THIS **PERMANENT SURVEY**. HIS FIELD NOTES ARE IN HIS BOOK NUMBER 3 ON PAGE 28, AND ADDITIONAL INFORMATION IS IN PACKET "M 85" IN MISCELLANEOUS DRAWER NUMBER 4 IN THE VAULT IN THE COUNTY ENGINEER'S OFFICE.
